

Early Childhood Education COVID-19 Guidelines & Preschool Family Handbook Addendum

EXCLUSION POLICY

General Exclusion Guidelines: If individuals have any of the following symptoms they **may not** attend. These symptoms are exclusionary regardless of COVID-19 status:

*vomiting, nausea, or diarrhea	*fever of 100 degrees or more
*unexplained rash w/out doctor clearance	*untreated head lice
*green/yellow runny nose paired w/ other symptoms	
*infectious pink eye (until cleared by a doctor and on antibiotics for 24 hrs)	

Individuals must be fever/vomiting/ diarrhea free for 24 hours w/out the aid of medication.

If program participant/staff has possible COVID-19 symptoms:

- No known exposure: Test before attending program. If negative follow CDC guidelines for testing with possible symptoms (including repeated testing and masking).
- **Known exposure:** Stay home and presume COVID. Follow CDC guidance to return (including repeated testing and masking).

If a program participant develops possible COVID-19 symptoms during class, they will be sent home until a guardian conducts a COVID test. We are happy to provide them! Staff will be isolated and given a test.

MASKING

Masks are not required but strongly encouraged when indoors in the following instances:

- on days 6-11 after having COVID-19
- within the 10 days after exposure to COVID-19
- when awaiting a 2nd test per FDA guidance after symptoms but no exposure

POSSIBLE COVID-19 SYMPTOMS*

- Fever of 100.4 deg. + OR chills
- Cough
- Difficulty breathing
- Nausea or vomiting
- Diarrhea
- New onset of severe headache
- New loss of taste or smell
- Sore throat

*For chronic conditions (ex: asthma) symptoms should represent a change from baseline. A doctor's note must be supplied listing this as a previously diagnosed condition. For **Preschool students**, this must appear on the health intake form.

Students developmentally unable to wear a mask will not be excluded from the program after an exposure. We will attempt to coach the child to mask, but will not require it.

All individuals and families may continue to wear masks as they are comfortable. Staff will attempt to encourage children to wear masks if families request, but please understand this will not be fail proof and it will be extremely difficult for children to wear a mask if all the other children are not required to.

COMMUNICATION

Irvine will inform families/staff if they/their child was exposed to COVID-19. All families/staff must promptly inform the Director if a student/staff tests positive, is notified of an exposure to, or develops any symptoms of COVID-19. Failure to promptly inform the Director may result in the unintentional spread of disease and possible termination or dismissal from Irvine Programs.
